**REVISED ADMISSION NOTIFICATION FOR 2 YEAR B.Ed. PROGRAMME 2022-2023**

Admission notification for 2 year B.Ed programme 2022-23 issued vide No.66741/DOA-ASST-6/2021/Admn dated 05.08.2022 is revised to include 11 Calicut University Teacher Education Centres (CUTEC) also in the ongoing admission process which started on 05.08.2022. Detailed list of CUTECs is provided in the revised 'B.Ed Prospectus 2022' available in the University Website. Candidates who have already applied for B.Ed programme can edit their application to give options for CUTECs till the last date of online application.

Online applications are invited for admissions to B.Ed. programme (Two years – 4 semesters) for the academic year 2022-2023 in the Government Colleges/Aided Colleges/ University Teacher Education Centres/Self Financing Colleges affiliated to University of Calicut.

All candidates seeking admission to B.Ed programmes including (General Merit / Reservation /Mahe/ Teacher Quota/ Sports / Defence/Persons with Disabilities / Linguistic minority/ Community/ Management etc) should compulsorily register through Centralized Admission Process (CAP). The candidates who have not registered through CAP will not be permitted to admission at any stage of the admission process.

1. **Eligibility** – Eligibility for admission to B.Ed programme will be available in the University website 'B.Ed Prospectus 2022'

2. **Mode of Registration:** Online

3. **Online Registration fee**

For SC/ST: Rs. 200/- (Rupees Two hundred only)

2. Minutes of the of the 402nd meeting of the SRC NCTE held on 13th&14th september 2021.

The University has noticed in the website of NCTE, of a decision in a virtual tele-conferencing of the Southern Regional Committee (402nd meeting held on 13th-14th september 2021 ), that it has taken a decision to cancel/withdraw the recognition of the Teacher Education Centres with effect from 28.11.2014 ie, the date of promulgation of the NCTE Regulations, 2014 and also has taken a decision to close down the Teacher Education Centres run by the University of Calicut.

University of Calicut has forwarded a reply to the letters received from SRC NCTE, viz Letters No.F.No.SRC/NCTE/397-AT/2021/126131 dated 16.04.2021, No. 399 -AT /2021/126672 dated 23/6/2021 with all relevant documents on 29.07.2021 ( **Annexure 1**). Due to the abrupt spreading of second wave of Covid-19 which badly hit in Kerala, the University was completely closed for months and then partially permitted to work with controlling measures during the pandemic period. This is the reason for the delay in furnishing the data.

I may say that the decision taken by the SRC is without taking into account the relevant aspects of the matter and also the binding judgments of the Hon'ble High Court of Kerala and the Interim Orders issued thereunder so also the decisions of the National Council.

The University of Calicut is running 11 Teacher Education Centres under its direct administration on cost sharing basis with an aim to uplift the marginalised and weaker section of the society. These Centres were established in different years (as shown in table) in tune with the growing demands of the student community with the support from State Government and financial assistance from the local people, MLAs and MPs. Till the starting of these centres students from the State had to approach teaching institutions outside Kerala. Many of these centres are located in remote, rural and under

developed areas under the jurisdiction of University of Calicut. The teachers are appointed according to the existing NCTE Norms, on a full time basis from the rank list prepared by a selection committee constituted by the Vice Chancellor strictly following the communal rotation as per KS & SSR. The teaching faculties are paid monthly salary with pay scale and is being granted yearly enhancement in the salary. This ensures the availability of full time dedicated and experienced teaching faculty which helps in maintaining the academic standard in the Teacher Education Centres of the University as stipulated by UGC and NCTE. Students are admitted purely on merit basis, adhering to reservation policy of the State. These Teacher Education Centres are of basic unit of 50 students each, among five districts namely Wayanad, Calicut, Malappuram , Palakkad and Thrissur. Yearly almost 550 students successfully complete their courses from CUTECs. The details of the institutions and the years in which it is established is furnished hereunder:

In the year 2009, an issue was raised by the Regional Director of the NCTE that since there is no permanent teachers appointed and that some of the institutions are not functioning in permanent buildings, so also the University has not made FDR, the recognition was withdrawn. The matter was taken up before the Hon'ble High Court of Kerala and the Hon'ble High Court issued a judgment on 17/8/2010 in W.P(c) No. 33636/2009. The copy of the judgment is enclosed herewith as **Annexure 2**. By Annexure 2, a liberty was given to the NCTE to recall the approval if the facilities pointed out by the NCTE in terms of the revised order to be issued in terms of the directions issued by the Hon'ble High Court and it has not been complied with.

In 2014, the Registrar, University of Calicut had remitted the mandatory fees for NCTE visit and give recognition to its 11 Teacher Education Centres. But , unfortunately, SRC-NCTE withdrew the recognitions of the 11 Centres without visiting the Centres. The Decision of SRC-NCTE in 2015 withdrawing the recognition in respect of teacher education centres of the University, is against the spirit of the above judgement.

In relation to **CUTEC, Calicut** a show cause notice was issued on 16/1/2015 to which the University submitted an explanation. But no orders are passed till now ( **Annexure 3**).

In relation to **CUTEC, Manjeri**, an order of withdrawal was issued on 23/09/2015 against which an appeal was filed on 25/2/2016 before the NCTE. The appeal committee NCTE had directed the SRC to set aside the decision conveyed to appellant institution and to reconsider the matter keeping in view the order of Hon.Highcourt of Kerala (WPC No.33636/2009). A true copy of the appeal order is produced herewith and marked as **Annexure 4**. No further communication is received from the NCTE.

In relation to **CUTEC, Koduvayur**, the withdrawal order was issued on 23/4/2015 and the matter was taken up in appeal before the NCTE on 3/7/2015 and the NCTE directed the SRC to reconsider the matter and to keep the withdrawal order in abeyance. A true copy of the appeal order is produced herewith and marked as **Annexure 5**. No further communication is received from the NCTE.

In relation to **CUTEC, Aranattukara**, an order of withdrawal was issued on 01/05/2015 against which an appeal was filed on 18/12/2015 before the NCTE. The appeal committee NCTE concluded that the appeal deserves to be remanded to SRC for consideration and necessary action. A true copy of the order of withdrawal and order of appeal are produced herewith and marked as **Annexure 6**. No further communication is received from the NCTE.

In relation to **CUTEC, Kaniyambetta**, an order of withdrawal was issued on 23/4/2015 against which an appeal was filed on 3/7/2015 before the NCTE. The NCTE had directed the SRC to reconsider the matter and to keep the withdrawal order in abeyance. A true copy of the appeal order is produced herewith and marked as **Annexure 7**. No further communication is received from the NCTE.

In relation to **CUTEC, Vatakara**, a show cause notice was issued to withdraw the recognition of the institution on 05.01.2015, reply was submitted by the institution. No further communication and withdrawal order was issued by SRC. On 22/03/2016 composite visit was done for M.Ed and B.Ed courses and SRC issued withdrawal order on 04/03/2017 to the M.Ed course ( **Annexure 8**). In fact the show cause notice was a composite notice to withdraw the institution as a whole, but when final orders are passed, it only related to M.Ed course and from that onwards M.Ed course is not conducting.

With reference to **CUTEC, Valappad**, the withdrawal order was issued on 15/5/2015 and the matter was taken in appeal before the NCTE on 3/7/2015. The NCTE had directed the SRC to reconsider the matter and to keep the withdrawal order in abeyance. A true copy of the appeal order is produced herewith and marked as **Annexure 9**. No further communication is received from the NCTE.

In relation to **CUTEC, Nattika**, an order of withdrawal was issued on 1/5/2015. An appeal was

preferred before the NCTE. But the appeal was not considered and the appeal was not taken up before the NCTE. Since no decision was taken, the matter was taken up before the Hon'ble High Court of Kerala in W.P(c) No. 26875/2016 and the Hon'ble High Court while ordering to consider the appeal, stayed the withdrawal/cancellation of the recognition granted. A true copy of the judgment in W.P.(c) 26875/2016 is produced herewith and marked as **Annexure 10**. The appeal is still to be heard or orders passed and the Interim Order of the Hon'ble High Court of Kerala is still in force.

In relation to **CUTEC, Sulthan Bathery**, an order of withdrawal was issued on 5/10/2015; against which an appeal was taken up before the Appellate Authority, the NCTE. The appeal was rejected by NCTE on the ground of inadequate built up area. Challenging the same a writ petition was filed before the Hon'ble High Court of Kerala as W.P(C) No. 26895/2016 (**Annexure 11**) and the Hon'ble High Court was pleased to admit the writ petition and issued Interim Orders staying the order of withdrawal of recognition, which is still in force.

In relation to **CUTEC, Malappuram**, an order of withdrawal was issued on 1/10/2015. An appeal was preferred before the NCTE. But the appeal committee rejected the appeal submitted on the ground that the appellant has not furnished FDR for endowment and Reserve fund and orders of the SRC is confirmed. Hence the matter was taken up before the Hon'ble High Court of Kerala in W.P(c) No. 26844/2016 and the Hon'ble High Court stayed the withdrawal/cancellation of the recognition granted for getting a reply from state government with regard to the FDR. A true copy of the judgment in W.P.(c) 26844/2016 is produced herewith and marked as **Annexure 12**.

In relation to **CUTEC, Chakkittappara** an order was issued on 1/5/2015, stating the reason that no regular staff is appointed and other small technical issues. The matter was taken up before the National Council for Teacher Education, the apex body. The apex body by order dated 3/7/2015 on allowing the appeal, remitted back for reconsideration to the SRC. The true copy of the appeal order is enclosed herewith as **Annexure 13**. Specific directions are also issued that the withdrawal should be kept in abeyance. Though the order was issued on 3/7/2015, no further orders were issued.

This is the factual position. The reasoning that no revised provisional recognition order is issued from 2014, on coming into force of NCTE Regulations is not correct and without considering the present status of the teacher education institutions.

I may say that all the institutions are managed by the University itself based on the recognition orders granted or based on the orders issued by the National Council or by the Hon'ble High Court of Kerala. Further, retrospective withdrawal recognition is not one contemplated or permissible under law as well. Also no notice is issued to the University in the matter. Despite getting favourable judgement from the Hon. High court of Kerala and the request of the University to visit the teacher education centres, SRC-NCTE has taken the decision to withdraw the recognition with retrospective effect.

Further all the institutions are managed by the University itself and under the direct supervision of a Director and a Principal. Hence, before issuing any formal orders in implementing the decision, it is requested that your goodself may take note of these aspects of the matter and request the Southern Regional Committee to reconsider the issue in the light of the factual and legal positions mentioned above. In due course of time we have rectified all the deficiencies pointed by the SRC and NCTE team

**PUBLIC NOTICE**


The National Council for Teacher Education is a Statutory Body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on 17<sup>th</sup> August 1995 to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

2. As per the provisions of the NCTE Act, 1993 and NCTE Regulations 2014, as amended from time to time, Performance Appraisal Report (PAR) is required to be submitted annually by the existing Teacher Education Institutions (TEIs). Accordingly, NCTE had issued a Public Notice on 22.09.2019 directing all TEIs running NCTE recognised Teacher Education Courses to file PAR for academic session 2018-19. The last date for submission of PAR was 31.12.2019, which was later on extended till 20.01.2020 (Mid night).
3. Aggrieved with the said Public Notice, a number of TEIs approached the Hon'ble High Court of Delhi in W.P. No. 11304/2019 and obtained stay thereon. Hon'ble High Court of Delhi in W.P. No. 11304/2019 pronounced the Judgment on 27.5.2021 upholding the decision of NCTE requiring the TEIs to file PAR. In view of decision of the Hon'ble High Court of Delhi, PAR was required to be mandatorily submitted by all TEIs for the academic session 2020-2021. Timeline to submit PAR was from 29.09.2021 to 28.01.2022 (mid night) which was later on extended till 15.03.2022.
4. The Division Bench of the Hon'ble High Court of Delhi, *vide* its Order dated 25 February 2022, while upholding the decision of the Single Bench extended the date of filing of PAR to 31<sup>st</sup> March, 2022.
5. Thereafter, the Hon'ble Supreme Court, *vide* its Order dated 01.04.2022 in SLP No. 5479/2022, decided that the TEIs would have to file PAR for the academic session 2020-21 by 2<sup>nd</sup> April, 2022.
6. The matter was placed before the General Body of the Council in its 54<sup>th</sup> meeting held on 27<sup>th</sup> April, 2022 and the Council *inter-alia* decided that with regard to the TEIs which have not filed PAR in compliance with Hon'ble Supreme Court's deadline of 2<sup>nd</sup> April, 2022, the academic session 2022-23 shall be declared as a zero academic year for fresh intake.
7. In view of the decision taken by the General Body of the Council, appropriate authorities/affiliating bodies concerned are hereby requested to take necessary action accordingly in

respect of the TEIs under their jurisdiction which have not filed PAR by 2<sup>nd</sup> April 2022, for academic session 2020-21, in compliance

with the order of the Hon'ble Supreme Court. A State-wise list of the institutions which have filed PAR for the academic session 2020-21 is attached herewith.


