Kerala Medical College established at Cherpulassery. Palakkad District has received an Essentiality Certificate from Govt. of Kerala vide Order No. 140/S3/2016/H&FWD dated 07/07/2016. The Chairman has informed that 150 students were admitted in the college during the academic year 2016-17 and continued their studies up to the academic year 2017-18. But these students admitted in this college were shifted to other 9 Self- financing Medical College, for want of infrastructure facilities and deficiency of faculties. At present, the College, Hospital and Landed property of Kerala Medical College owned and occupied by a New Management. The New Management rectified all deficiencies pointed out by Medical Council of India and the Kerala University of Health Sciences during their inspection. The Board of Governors in Supersession of Medical Council of India vide letter no.MCI-34(41)(E-21)/2019- Med./163494 dated 11/11/2019 directed to apply for next academic section for approval of the MBBS programs in the Medical College. In the circumstances the Chairman has requested to issue the revalidated NOC and Essentiality Certificate to restart the MBBS programmes in the current academic year.

It may be noted that the Essentiality Certificate is only one of the formalities to be cleared for obtaining letter of permission from MCI to run the MBBS course in the institution. Univeristy/DME may be requested to conduct an inspection and report whether the college has got the requisite infrastructure to run the course. For orders

The Kerala Medical College established at Cherpulassery, Palakkad District has received an Essentiality Certificate from Govt. of Kerala and 150 students were admitted in the college during the academic year 2016-17. They continued their studies up to the

academic year 2017-18. But these students were shifted to other 9 Self- financing Medical College, for want of infrastructure facilities and deficiency of faculties. At present, the College, Hospital and Landed property of Kerala Medical College owned and occupied by a New Management and they have informed that, they have rectified all deficiencies pointed out by Medical Council of India and the Kerala University of Health Sciences during their inspection. The Board of Governors in Supersession of Medical Council of India vide letter no.MCI-34(41)(E-21)/2019- Med./163494 dated 11/11/2019 directed to apply for next academic section for approval of the MBBS programs in the Medical College. In the circumstances the Chairman has requested to issue the revalidated NOC and Essentiality Certificate to restart the MBBS programmes in the current academic year.

But, Now a days Government have avowedly revealed its stand to not to issue Essentiality Certificate for opening of new medical graduate courses in the state. In the circumstances, for orders whether we may stick on our stand or whether steps may be taken to re validate the E.C as requested by the College authorities.

They have represented that they have cleared all the deficiencies pointed out by the MCI and hence have requested to grant essentiality certificate. In the wake of the recent pandemic our country is facing acute shortage of medical personnels and medical facilities. Hence it is better to give them a chance to prove their merit. So its better to conduct an inspection in the college and to see that the college fulfils all the requirements of a medical college. Hence the university may be directed to conduct an inspection in the college and to report whether the college qualifies all the criteria which is necessary for the functioning of a medical college. Notes above. The request is for revalidation of Essentiality Certificate in r/o Palakkad Medical College, Cherppulassey which has become defunct subsequent to the failure to run the college due to mismanagement, fraudulence and financial instability and pursuant to it the responsibility of protecting the students of that college fell upon Government as Government was bound to abide by the particular clause in the Essentiality Certificate guaranteeing the responsibility of the students in case of failure by the management. The students and parents of Palakkad Medical College, Cherppulassey cited the very same clause for intervention by Government before the court and obtained favourable orders. As such the students were shifted to other 9 Selffinancing Medical Colleges. The parents of SR Medical college are also suing before the court with the same request citing the very same clause and the GOI invoking the said provision in the Essentiality certificate has already directed the state Government to distribute the students to other private medical colleges. At present, the College, Hospital and Landed property of Kerala Medical College are owned and occupied by a New Management. As everybody knows self financing medical Educational institutions are nothing but business enterprises now a Government machinery need not at all cater to any business interest. Learning lessons from the litigations in this regard and also from the conviction that we are having surplus medical graduates Government have avowedly taken their stand to not to issue Essentiality Certificate for opening of new medical colleges in the state. There is already another general file with regard to the request putin by various self financing medical colleges for Essentiality certificate from Government for enhancement of **medical seats** which is now with the Minister (H) pending decision.

That being the situation it is submitted for orders whether we need give them a chance to prove their merit as suggested above.

The students and parents of Palakkad Medical College, Cherppulassey cited the very same clause for intervention by Government before the court and obtained favourable orders. The parents of SR Medical college are also suing before the court with the same request citing the very same clause. Hence it is brought to the attention that it is not advisable to issue Essentiality Certificate bearing the above stated wordings to any of the self financing colleges again.

From the above it is seen that it is high time to evolve a steady policy in this matter. In this connection it may be pointed out that among the self financing medical colleges in the state, two of them have already failed to run the college due to mismanagement, fraudulence and financial instability and the responsibility of protecting the students fell upon Government as Government are bound to abide by the particular clause in the Essentiality Certificate guaranteeing the responsibility of the students in case of failure by the management. In the case of SR Medical college Government is at present on the brink of an embarrassing situation that only a few colleges came up to share the students(only two in number have valid recognition and it is heard that between the two one has already backed out). In such a situation on the strength of the said dangerous clause as contained in the Essentiality Certificate we will even be compelled to accommodate the students in Government sector if court directs so citing the said clause). It is learned that many of the colleges are trailing towards such pathetic plight. On getting Essentiality Certificate, as we all know, many of the managements start playing dirty tricks and finally manages to get through the MCI assessment hook or crook fooling the MCI team as happened in the above two mentioned colleges. The net result is putting the students in jeopardy and total compromise of quality education. Recently in a judgement by the Supreme court I remember to have come across the wordings of the Apex court slamming the Bihar Government stating that they are producing half baked doctors. As everybody knows self financing medical Educational institutions are nothing but pure enterprises and mushrooming of the same is no doubt a criminal trend which should be deprecated to the core especially in a state like Kerala.

In the above circumstances it is suggested that Govt. on public interest may evolve a consistent stand not to entertain neither any request from the Self financing Medical Colleges to enhance the seats nor any request for starting new Medical Colleges.



As per read (3) above, the Chairman, Kerala Medical College, Palakkad has submitted the affidavits and undertaking as directed by the University and deposited Rs. 50 lakh in the University account as refundable deposit (interest free). The college has also remitted Rs. 10 lakh as provisional affiliation fee and Rs. 20 lakh as refundable deposit.
- 5. Sanction, has therefore been accorded by the Vice-Chancellor, in exercising the powers conferred under Section 12(7) of Kerala University of Health Sciences Act, 2010 to grant conditional provisional affiliation to Kerala Medical College, Palakkad for conducting MBBS course with an annual intake of 150 seats during the academic year 2016-17 subject to ratification by the Governing Council and the conditions detailed below:
 - 1. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University/Govt. of Kerala from time to time, failing which the affiliation granted will be cancelled.
 - 2. Affiliation granted is subject to the out come of the inspection to be conducted at the college.
 - 3. The University shall forfeit Rs. 50 lakh (interest free) being kept as financial guarantee and Rs. 20 lakh being the refundable deposit for starting the college, if the University finds that the college is lacking minimum requirements needed for conducting medical college with MBBS course having annual intake of 150 seats.
 - 4. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
 - 5. Affiliation granted is strictly provisional and only for the academic year 2016-17. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
