

As per the provisions of Section 29 (2) of the Thunchath Ezhuthachan Malayalam Uty. Act,2013. " *the VC shall be appointed by the Chancellor on the advice of the Search Committee consisting of a nominee of the Chancellor, a representative of the Govt. and a representative of the UGC. The nominee of the Chancellor shall be the chairmen of the Search Committee.*

As per Clause 7.3.ii of the UGC Regus, 2018, "*the members of the Search - cum- Selection Committee shall be persons of eminence in the sphere of higher education and shall not be connected in any manner with the Uty. concerned or its colleges*".

Clause 7.3 of the UGC Regus. 2018 stipulates the following:

7.3. VICE CHANCELLOR

ii). The selection for the post of Vice- Chancellor should be through proper identification by a panel of 3-5 persons by a Search - cum - Selection Committee, through a public notification or nomination or a talent search process or a combination thereof. The members of Search - cum - Selection Committee shall be persons' of eminence in the sphere of higher education and shall not be connected in any manner with the University concerned or its colleges. While preparing panel, the Search - cum - Selection Committee shall give proper weightage to the academic excellence, exposure to the higher education system in the country and abroad, and adequate experience in academic and administrative governance, to be given in writing along with the panel to be submitted to the Visitor/ Chancellor. One member of the Search - cum - Selection Committee shall be nominated by the Chairmen, UGC , for selection of Vice Chancellors of State, Private and Deemed to be Universities. (p. see cf p. 5-7).

CHAPTER- V

OFFICERS OF THE UNIVERSITY

28. *Officers of the University*- The following shall be the officers of the University namely:-

- (i) the Vice - Chancellor;
- (ii) the Pro- Vice -Chancellor;
- (iii) the Registrar;
- (iv) the controller of Examinations;
- (v) the Finance Officer;
- (vi) the Deans of Faculties;
- (vii) the Directors of Schools;
- (viii) the University Librarian;
- (ix) the Curator of the University Museum;
- (x) any other persons declared by the Statutes to be the officer of the University.

29. *The Vice Chancellor* -(1) The Vice chancellor shall be a full time officer of the university.

(2) The Vice- Chancellor shall be appointed by the Search Committee is not unanimous, the Chancellor may accept the opinion of the majority of its members.

(3) The Search Committee may establish its own procedure for securing the names of eligible candidates for consideration from individuals & bodies as it considers appropriate.

(4) Notwithstanding anything contained in sub-section (2), the first Vice - chancellor, after commencement of his Act shall be appointed by the Chancellor for a period not exceeding five years on such terms & conditions as the chancellor may determine.

(5) The Vice - Chancellor shall hold office for a term of 5 years and shall be eligible for re -appointment for one more term:
Provided that a Vice - Chancellor appointed under this section shall cease to hold office on his completing the age of sixty five years.

(6) The emoluments, perquisites and other service conditions of the Vice - Chancellor shall be such as may be prescribed.

(7) The Vice Chancellor may resign his office by conveying in writing to the Chancellor.

(8) The resignation of the Vice Chancellor shall take effect from the date of

the Chancellor accepting it and relieving him from the duties.

(9) In the event of a temporary or permanent vacancy occurring in the office of the Vice - Chancellor, the Chancellor shall make necessary interim arrangements till the vacancy is duly filled in accordance with the provisions of sub-section (2) and such interim arrangement shall not ordinarily continue for more than three months.

30. *Powers & duties of the Vice Chancellor*-(1) The Vice Chancellor shall be the principal executive & academic officer of the University & ex-officio Chairman of the Executive Committee & the academic Council & shall, in the absence of the chancellor & Pro- chancellor, preside at the meetings of the General Council and at the convocation of the University & confer degrees on persons entitled to receive them.

(2) The Vice - Chancellor shall exercise general control over the affairs of the University and shall be responsible for the proper management and administration of the University.

(3) The Vice - Chancellor shall convene meeting of the General Council, the Executive Committee and the Academic Council.

(4) The Vice - Chancellor shall ensure faithful observance of the provisions of this Act, the Statutes, Ordinances and Regulations and may exercise such powers as may be necessary for this purpose.

(5) The Vice - Chancellor shall be responsible for the presentation of the budget estimates and the annual accounts to the Executive Committee and the General Council.

(6) The Vice- Chancellor may take any action in an emergency which in his opinion calls for immediate action and shall in such cases , report the action so taken in the next meeting of the Executive Committee.

(7) Any persons aggrieved by any order of the Vice- Chancellor may appeal to the Executive Committee.

(8) The Vice - Chancellor shall give effect to the decisions of the General Council and the Executive Committee.

(9) The Vice- Chancellor shall be responsible for the proper co-ordination of the various departments of the University.

(10) Subject to the provisions of this Act and statutes the Vice- Chancellor shall with the approval of the Executive Committee appoint the teachers and other employees of the University.

(11) Subject to ratification by the Executive Committee, the Vice- Chancellor shall have the power to suspend the teachers and other employees of the University and to take disciplinary action against them.

(12) The Vice Chancellor shall exercise supervision and control over the discipline among students.

(13) The Vice- Chancellor shall take up activities that are meant to ensure the wellbeing and welfare of the teachers, staff and students of the University.

(14) The Vice Chancellor shall exercise such other powers as may be prescribed for carrying out the purpose of this act.

31. *Pro- Vice-Chancellor-* (1) The Chancellor shall appoint a Pro- Vice Chancellor for the University.

(2) The Persons so appointed shall not be above the age of fifty six years.

(3) The term of appointment of the Pro-Vice- Chancellor shall be five years from the date on which he enters his office and shall be a whole time officer of the University.

(4) The salary and other conditions of service of the Pro- Vice – Chancellor shall be as prescribed by the statutes.

(5) Subject in the provisions the Act, Statutes, Ordinances and Regulations, the powers and functions of the Pro-Vice-Chancellor shall be determined by the Chancellor ,in consultation with the Vice-Chancellor.

32. *The Registrar-*(1) The registrar shall be a full time officer of the University & shall be appointed in such manner in accordance with the Statutes.

(2) The registrar shall be responsible for the due custody of the common seal of the University.

(3) The Registrar shall be the ex-officio Secretary to the General council and the Executive Committee and the Academic Council shall be responsible for the proper recording of their proceedings and for placing before such authorities all such matters as may be necessary for the transaction of their business.

(4) The Registrar shall receive applications for admission for the various courses of the University and shall keep permanent record of all courses, curricula and other information as may be deemed necessary by the Academic Council.

(5) The Registrar shall perform such other duties as may be prescribed or which may be assigned by the Executive Committee or the Vice Chancellor.

(6) The registrar shall be appointed for a term not exceeding five years and shall be entitled for the emoluments and other service conditions as may be prescribed.

UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018

No. F.1-2/2017(EC/PS).—In exercise of the powers conferred under clause (e) and (g) of sub-section(1) of Section 26 read with Section 14 of the University Grants Commission Act, 1956 (3 of 1956), and in supersession of the "UGC Regulations on Minimum qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010" (Regulation No.F.3-1/2009 dated 30th June, 2010) together with all amendments made therein from time to time, the University Grants Commission, hereby, frames the following Regulations, namely:-

1. Short title, application and commencement:

- 1.1 These Regulations may be called the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulations, 2018.
- 1.2 These shall apply to every University established or incorporated by or under a Central Act, Provincial Act or a State Act, every Institution including a Constituent or an affiliated College recognized by the Commission, in consultation with the University concerned under Clause (i) of Section 2 of the University Grants Commission Act, 1956 and every Institution deemed to be a University under Section 3 of the said Act.
- 1.3 These shall come into force from the date of notification.
2. The Minimum Qualifications for appointment and other service conditions of University and College teachers, Librarians, and Directors of Physical Education and Sports as a measure for the maintenance of standards in higher education, shall be as provided in the Annexure to these Regulations.
3. If any University contravenes the provisions of these Regulations, the Commission after taking into consideration the cause, if any, shown by the University for such failure or contravention, may withhold from the University, the grants proposed to be made out of the Fund of the Commission.

UGC REGULATIONS ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND OTHER MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION, 2018**Minimum qualifications for the posts of Senior Professor, Professors and Teachers, and other Academic Staff in Universities and Colleges and revision of pay scales and other Service Conditions pertaining to such posts.****1.0 Coverage**

These Regulations are issued for minimum qualifications for appointment and other service conditions of University and College teachers and cadres of Librarians, Directors of Physical Education and Sports for maintenance of standards in higher education and revision of pay-scales.

- 1.1 For the purposes of direct recruitment to teaching posts in disciplines relating to university and collegiate education, interalia in the fields of health, medicine, special education, agriculture, veterinary and allied fields, technical education, teacher education, norms or standards laid down by authorities established by the relevant Act of Parliament under article 246 of the Constitution for the purpose of co-ordination and determination of standards in institutions for higher education or research and scientific and technical institutions, shall prevail
 - i. Provided that where no such norms and standards have been laid down by any regulatory authority, UGC Regulations herein shall be applicable till such time as any norms or standards are prescribed by the appropriate regulatory authority.
 - ii. Provided further that for appointment to the post of Assistant Professor and equivalent positions pertaining to disciplines in which the National Eligibility Test (NET), conducted by the University Grants Commission or Council of Scientific and Industrial Research as the case may be, or State level

IV. The criteria for CAS Promotions from University Deputy Director Physical Education and Sports/College Director Physical Education and Sports (Academic Level 13A) to University Deputy Director Physical Education and Sports/College Director Physical Education and Sports (Academic Level 14) shall be the following:

- 1) He/she has completed three years of service.
- 2) He/she has done any one of the following during last three years: (i) Completed one course / programme from among the categories of Refresher Courses, Research Methodology Workshop, (ii) Teaching-Learning-Evaluation Technology Programmes / Faculty Development Programmes of at least two weeks (ten days) duration (or completed two courses of at least one week (five days) duration in lieu of every single course/programme of at least two weeks (ten days) duration), (iii) Taken / developed one MOOCs course in relevant subject (with e-certification).
- 3) Evidence of organising competitions and coaching camps of at least two weeks' duration.
- 4) Evidence of having produced good performance of teams/athletes for competitions like state/national/inter-university/combined university, etc.
- 5) A Ph.D. in Physical Education or Physical Education and Sports or Sports Science.

CAS Promotion Criteria:

An individual may be promoted if;

- i) He/she gets a 'satisfactory' or 'good' grade performance assessment reports of at least two out of the last three years of the assessment period as specified in Appendix II, Table 5, and;
- ii) The promotion is recommended by a selection committee constituted as per these Regulations on the basis of the interview performance.

6.5. Discretionary award of advance increments for those who enter the profession as Associate Professor or Professor with higher merit, high number of research publications of high quality and experience at the appropriate level, shall be within the competence of the appropriate authority of the University concerned or recruiting institution based on the recommendations of a selection committee while considering the case of individual candidates in the context of the merits of each case, taking into account the pay structure of other teachers in the faculty and other merit-specific factors. Discretionary award of advance increments is not applicable to those entering the profession as Assistant Professor/Assistant Librarian/Assistant Director of Physical Education and Sports and to those who are entitled for grant of advance increments for having acquired a Ph. D., M. Phil. or M.Tech. and I.L.M degree. However, those entering the service as Assistant Professor/Assistant Librarian/Assistant Director of Physical Education and Sports, having a post-doctoral teaching/research experience, after obtaining a Ph.D. degree and proven credentials, may be eligible for discretionary award of advanced increments to be given to the person, as decided and recorded by the Selection Committee in the minutes of its meeting.

7.0 SELECTION OF PRO-VICE CHANCELLOR / VICE - CHANCELLOR OF UNIVERSITIES:

7.1 PRO-VICE-CHANCELLOR:

The Pro-Vice-Chancellor shall be appointed by the Executive Council on the recommendation of the Vice-Chancellor.

7.2 It shall be the prerogative of the Vice-Chancellor to recommend a person to be the Pro-Vice-Chancellor to the Executive Council. The Pro-Vice-Chancellor shall hold office for a period, which is co-terminus with that of the Vice-Chancellor.

7.3. VICE CHANCELLOR:

- i. A person possessing the highest level of competence, integrity, morals and institutional commitment is to be appointed as Vice-Chancellor. The person to be appointed as a Vice-Chancellor should be a distinguished academician, with a minimum of ten years' of experience as Professor in a University or ten years' of experience in a reputed research and / or academic administrative organisation with proof of having demonstrated academic leadership.
- ii. The selection for the post of Vice-Chancellor should be through proper identification by a Panel of 3-5 persons by a Search-cum-Selection-Committee, through a public notification or nomination or a talent search process or a combination thereof. The members of such Search-cum-Selection Committee shall be

persons' of eminence in the sphere of higher education and shall not be connected in any manner with the University concerned or its colleges. While preparing the panel, the Search cum-Selection Committee shall give proper weightage to the academic excellence, exposure to the higher education system in the country and abroad, and adequate experience in academic and administrative governance, to be given in writing along with the panel to be submitted to the Visitor/Chancellor. One member of the Search cum-Selection Committee shall be nominated by the Chairman, University Grants Commission, for selection of Vice Chancellors of State, Private and Deemed to be Universities.

- iii. The Visitor/Chancellor shall appoint the Vice Chancellor out of the Panel of names recommended by the Search-cum-Selection Committee.
- iv. The term of office of the Vice-Chancellor shall form part of the service period of the incumbent making him/her eligible for all service related benefits.

8.0 DUTY LEAVE, STUDY LEAVE, SABBATICAL LEAVE

8.1 DUTY LEAVE:

- i. Duty leave upto 30 days in an academic year may be granted for the following purposes:
 - (a) Attending Orientation Programme, Refresher Course, Research Methodology Workshop, Faculty Induction Programme, Conference, Congresses, Symposia and Seminar, as a delegate nominated by the university or with the permission of the university/college;
 - (b) Delivering lectures in institutions and universities at the invitation of such institutions or universities received by the university, and accepted by the Vice-Chancellor/Principal of the College;
 - (c) Working in another Indian or foreign university, any other agency, institution or organisation, when so deputed by the university/College;
 - (d) Participating in a delegation or working on a committee appointed by the Central Government, State Government, the UGC, a sister university or any other similar academic body; and
 - (e) For performing any other duty assigned to him/her by the university/college.
- ii. The duration of leave should be such as may be considered necessary by the sanctioning authority on each occasion.
- iii. The leave may be granted on full pay, provided, that if the teacher receives a fellowship or honorarium or any other financial assistance beyond the amount needed for normal expenses, he/she may be sanctioned duty leave on reduced pay and allowances.
- iv. Duty leave may be combined with earned leave, half pay leave or extraordinary leave, or Casual leave.
- v. Duty leave should be given also for attending meetings in the UGC, DST, etc. where a teacher is invited to share his/her expertise with an academic body, government agency or NGO.

8.2 STUDY LEAVE:

- i. The scheme of Study Leave provides an opportunity to avail of scholarships/fellowships awarded to the faculty who wish to acquire new knowledge and to improve analytical skills. When a teacher is awarded a scholarship or stipend (by whatever nomenclature called), for pursuing further studies, leading to a Ph.D./Post-doctoral qualification or for undertaking a research project in a higher education institution abroad, the amount of the scholarship/fellowship shall not be linked to the recipient's pay/salary paid to him/her by his/her parent institution. The awardee shall be paid salary for the entire duration of fellowship/scholarship, provided, that he/she does not take up any other remunerative jobs, like teaching, in the host country.
- ii. A teacher on Study Leave shall not take up, during the period of that leave, any regular or part-time appointment under an organisation in India or abroad. He/she may, however, be allowed to accept a fellowship or a research scholarship or an ad-hoc teaching and research assignment with an honorarium or any other form of assistance, other than the regular employment in an institution either in India or abroad, provided, that the Executive Council/Syndicate of his/her parent institution may, if it so desires, sanction study leave on reduced pay and allowances to the extent of any receipt in this regard, in-lieu of teaching etc., which may be determined by his/her employer.
