As per the G.O read as 1st paper above, Sri.P.V.Unnikrishnan Maintenance Engineer (Electronics) Kerala State Film Development Corporation Ltd. was provisionally appointed as Registrar, C-DIT on N.2200-75-2800-100-4000 retaining his lien in the Kerala State Film Development Corporation. Accordingly he was relieved from the KSFDC with effect from 4-6-90 and joined in C-DIT as Registrar. As per the G.O read as 2nd paper above, the provisional appointment of Sri.P.V. Unnikrishnan as Registrar, C-DIT was terminated forthwith and he was reverted back to the Kerala State Film Development Corporation and accommodated against the vacant post of Projet Engineer, upgrading it to that of Maintenance E.gineer(Electronics) so long as he hold the post. As per the Government letter read as 3rd paper above, Government directed the Director of C-DIT to relieve Sri.P.V.Unnikrishnan from the post of Registrar of C-DIT and to give full additional charge of the post of Registrar, C-DI to Sri.K. Kannan, Deputy Director QTAAS) C-DIT, purely as a temporary arrangements. Sri.P.V. Unnikrishnan went on deputation to Bharatgyan Vigjan Samithi (BGVS) on 10-5-96 from the Kerala State Film Development Corporation. As per G.O read as 4th paper above, Sri.T.R. Lalan Maintenance Engineer, KSFDC was ordered to hold additional charge of Registrar, C-DIT until further orders in the place of Sri.K. Kannan the then Registrar who was on leave.

- 2. As per G.O read as 5th paper above, Sri.P.V. Unnikrishnan, Maintenance Engineer (Electronics) has been appointed as Registrar C-DIT on provisional basis and his lien has been retained in the Kerala State Film Development Corporation.
- 3. The Director of C-DIT has in his mote read as 6th paper above requested that final orders cancelling the reversion of Sri.P.V.Unnikrishnan to Kerala State Film Development Corpo. As project Engineer and reappoint inghim as Registrar, C-DIT protecting his pay and service benefits as if he had continued in the C-DIT.

Sub: Sanctioning of revised scale of pay of the post of Registrar to P.V.Unnikrishnan – orders issued.

Ref. 1. G.O (MS) No.45/96/CAD dated 19.08.1996.

2. Decision of the 5th Governing Body meeting vide Agenda item No.6.

As per Rule 26 (1) and 26(3) of the Rules and Regulations of the Society, the Registrar shall be appointed by the Government. Similarly Rule 6 (vi) stipulates that "The Registrar shall be a full time salaried officer and shall be appointed by the Government, on the recommendations of the Director of the Society". Accordingly, Shri.P.V.Unnikrishnan, who was working as Project Engineer in KSFDC on his reversion from the post of Registrar, C-DIT, was reappointed as Registrar, C-DIT by the Government vide G.O cited first above in the scale of pay of Rs.2200-4000. He joined duty on 22.08.1996 (AN).

The 5th Governing Body at its meeting held on 29.01.1997 had approved vide Agenda item No. 6, the revised staff pattern and scales of pay for various categories of posts in C-DIT with retrospective effect from the starting of the society, accepting the recommendations of the sub-committee constituted for this purpose and of the Executive Committee. As per this, the scale of pay of the post of Registrar, has been revised as 4500-150-5700 with effect from the commencement of the society. However, Governing Body had also decided that monetary benefits for the revised scales of pay for all posts would be given with effect from 01.08.1996 only.

The Government had appointed Shri.P.V.Unnikrishnan in the pre-revised scale of pay of Rs.2200-4000 prior to this decision. The Government has been requested for sanctioning of revised scale and regularisation of the previous tenure of Shri.P.V.Unnikrishnan in the post of Registrar by cancelling the Govt. Order dated 24.10.1991 reverting him to KSFDC. The Government decision is awaited.

Meanwhile, Shri.P.V.Unnikrishnan has completed 10 years of R&D / teaching /professional service, prescribed as per the staff pattern (CSIR) adopted by Governing Body for the scale of pay of Rs.4500-150-5700 fixed for the post of Registrar and has requested for sanctioning of the revised scale to him. The matter has been examined and it is decided that Shri.P.V.Unnikrishnan, will be allowed to draw the revised scale of pay of Rs.4500-150-5700 for the post of Registrar with effect from 03.08.1997. i.e. the date of completion of 10 years service. His pay is refixed as follows.

Pay as on 03.08.1997 : 4500 Pay as on 01.08.1998, with one increment : 4650

He shall be eligible to drawn the salary arrears with effect from the due dates as above.

The above order is subject to the final decision of the Government on the matter of sanctioning of revised scale of pay to Shri.P.V.Unnikrishnan by regularising his previous tenure as Registrar. Shri.P.V.Unnikrishnan shall furnish an undertaking to refund any money payable subject to Government decision as above, before drawing pay in the revised scale.
