1. As per the G. O. cited (2) above, Government have amended Part II of the Rules of Business and entrusted the subject of framing and issuing of Special Rules to the Administrative Department concerned in respect of the Departments which come under its administrative control. As per the G. O. cited (4), the requirement of placing the Special Rules before the Council of Ministers for approval has also been dispensed with. The Circular sixth cited was issued detailing the simplified procedure for framing and issuing Special Rules.

GCPT. 3/3109/2010/2,000/DTP.

- 2. It has been observed that as per the instructions in para 250 of the Secretariat Office Manual, rule 59 of the Rules of Business and in Chapter 5 of the Law Department Manual, scrutiny of draft statutes, regulations and statutory rules, orders and notifications by the Law Department is mandatory and hence all Administrative Department should send the relevant files with sufficient details to Law Department for the purpose.
- 3. In the circumstances in modification of the Circular sixth cited, it is instructed that the following step by step procedure should be followed with regard to the framing and issue of Special Rules.
 - (i) The Administrative Department will prepare the draft Special Rules in consultation with or on receipt of proposal from the Head of Departments.
 - (ii) The next step is to discuss the draft Special Rules with the representatives of the common service organizations and other recognized service organizations, if any, in the department, at a meeting to which a representative of the Personnel and Administrative Reforms Department and Law Department will also be invited. The intimation regarding the discussion along with the draft rules should be sent to the Personnel and Administrative Reforms Department and to Law Department and the representatives of the service organizations concerned fifteen days before the proposed discussion so as to enable them to come prepared.
 - (iii) Thereafter the file should be sent to Personnel and Administrative Reforms Department for scrutiny of the draft notification.
 - (iv) The draft Special Rules should then be placed before a committee consisting of the following: (1) The Secretary of the Administrative Department (Chairman and Convener), (2) Secretary, Personnel and Administrative Reforms Department or his representative, (3) Law Secretary or his representative, (4) Head of the Department. The Administrative Department should send a copy of the draft Special Rules to the members of the committee at least fifteen days before the proposed meeting to provide sufficient time for scrutiny. The representative of the Personnel and Administrative Reforms Department will then offer the views of his/her department in the meeting itself.

- (v) Thereafter the file should be sent to the Law Department for scrutiny of the draft Special Rules.
- (vi) The Administrative Department should then refer the proposal to the Kerala Public Service Commission for advice. The draft of the letter forwarding the draft Notification to Kerala Public Service Commission shall be shown to Personnel and Administrative Reforms Department. After considering the advice of the Kerala Public Service Commission, the Administrative Department will finalise the draft Special Rules.
- (vii) The Administrative Department should then send the draft Special Rules to the concerned Subject Committee for consideration. After considering the recommendation, if any, of the Subject Committee, the Administrative Department will finalise the Special Rules. In case of special urgency like court directions having time-limit etc. the alternative procedure of issuing the Special Rules and simultaneously transmitting a copy of the same to the Subject Committee can be followed.
- (viii) The finalized draft Special Rules should then be approved and issued as an S. R. O. notification in the Gazette.
- (ix) It is not within the ambit of the above procedures to finalise matters which require separate decision and orders from Government, such as proposals in regard to creation of new category, grades, change in the status of the post, alternation of ratio/percentage of promotion/by-transfer etc.
- (x) 200 copies of the S. R. O. so issued shall be forwarded to the Secretary, Legislature Secretariat as soon as possible for being laid before the Legislative Assembly as required under Section 2(2) of Kerala Public Services Act, 1968.

The selection test for Category 7 (Motor Driver) will include Driving Test also. Candidates having Instructor Training Certificate obtained from DGT shall be given preference over other candidates.
- **05.** *Appointing authority*:- The appointing authority of all Categories under Craftsmen Training Subordinate Service shall be the Head of the Department.

06. Mandatory Training:-

- (i) Those who are entering in the Craftsmen Training Subordinate Service have to pass the obligatory training, mandated by the Director General of Training (DGT) from time to time.
- (ii) Every member in the service will have to compulsorily complete the training successfully within a period of three years from the date of declaration of probation in their entry cadre in Kerala Craftsmen Training Subordinate Service Rules.
- (iii) The officials whose retirement is due within three years and continuing in the entry cadre shall be exempted.
- (iv) Deputation of officials to the training shall be based on the seniority of officials in Category 4 (Trade wise).

(A) **Probation**:- Every person appointed to any of the categories shall, from the date on which he joins duty, be on probation-

- (i) if appointed by Direct Recruitment or by transfer through Kerala Public Service Commission, or by transfer to a category for which Direct Recruitment is one of the methods of appointment, for a total period of two years on duty within a continuous period of three years;
- (ii) if appointed by transfer to a category to which Direct Recruitment is not one of the methods of appointment for a period of one year duty within a continuous period of two years, and
- (iii) if appointed by promotion, for a total period of one year on duty within a continuous period of two years.
- **(B) Pre-service training**:- Candidates selected through special recruitment or Direct recruitment to Category 2 must undergo pre-service training for a period of six months and that training period will not be counted for seniority and probation.
- **08. Reservation of appointment:-** The rules regarding reservation of appointment in the General Rules 14-17 of the KS&SSRs 1958 shall apply to appointments by direct recruitment to the service. There is no reservation for by transfer appointments.
- **09.** *Physical standard*:- In addition to the norms prescribed in general rules, differently abled candidates belonging to the following categories viz (1) Blindness, (2) Hearing Impairments (Deaf), (3) Intellectual Disability, (4) Speech and Language Disability, (5) Multiple Disabilities and (6) Learning Disabilities are not eligible for appointment to the posts that come under the purview of Kerala Craftsmen Training Subordinate Service Rules.
- 10. Abolishment of Trades:- If a trade is abolished by DGT, the officials in the post of Junior/Senior Instructors & Workshop Attenders will be re-categorized to the newly started trades, subject to the condition that the new trade will be in the same sector in which the abolished trade belongs to. Experience obtained by Workshop Attender in the abolished trade will be considered for promotion to the post of Junior Instructor subject to the condition that the official shall be deputed for Craft Instructor Training at Central Institutes as soon as possible. If the official failed to complete the course successfully, after availing three chances the official

shall be reverted to Workshop Attender cadre with effect from the date of publication result of the third attempt. Such an official will be considered for promotion only after successful completion of Craft Instructor Training.

11. Savings - All persons who are members of this service as on the date of commencement of these rules shall be given exemption from possessing the qualifications prescribed by these Rules for the posts held by them as on the date of commencement of these rules.

Explanatory Note

(This does not from part of the notification, but it is intended to indicate its general purport)

Various new courses which require additional qualification have been introduced by the Department. To keep pace with the changing times and technological developments, various new trades and schemes like PPP & CoE have been introduced in the State by DGT, Government of India. In addition to infusion of funds for technological upgradation there is a need for restructuring the human resource base of the Industrial Training Institutes. Therefore the Special Rule has been drafted taking into account the need for quality and trained man power to meet the future training needs of the Department.

The 'Special Rules' in GO (P) 408/71/PD dated 29.11.1971 was formulated 34 years ago, when Industrial Training Department was conducting training in about 12 CTS trades, through 9 ITIs, in the state. Now there are about 100 ITIs functioning in the State and further expansion is in air. Number of trades, imparting training at ITI are also incresed. Trades have been throughly revamped with syllabus revision and schedule of training varying from 6 months to 3 years duration, according to the needs of the industry. The scheme and schedule of the Central Staff Training Institute (CTI) has also been modified as per DGT

guidelines. Qualification to the post of Instructors, framed by DGT as per the requirements of Industry. Strict enforcement of the rule regarding training is also compulsory for promotion benefits etc. Various new courses which require additional qualifications have been started.

In the circumstances an elaborate study was conducted and the draft Special Rules has been prepared, meticulously considering the special needs of this Department. These rules covers qualification of Instructors for all trades of CTS and Basic and Advanced modules of all CoE sectors which are being conducted in the state. This Rule is structured in such a way that the selection to various categories and posts in the Department will be done by the Kerala Public Service Commission.

These special rules have been created to comply with the directions given in WP(C)7765 of 2011(U) and subsequent G.O.(Rt) 89/2010/LBR dated 15/01/2010. The qualification of Motor Driver is fixed as per DGT norms in the Training Manual. These rules will enable the Motor Driver to assist to practice driving for trainees in Motor Mechanic Vehicle trade and such similar trades in the department.

This notification is intended to achieve the above object.
