**MINUTES OF THE THIRD MEETING OF THE SYNDICATE OF APJ
ABDUL KALAM TECHNOLOGICAL UNIVERSITY HELD ON 4th
FEBRUARY 2019 AT 10.30 P.M.**

The third meeting of the Syndicate of the APJ Abdul Kalam Technological University was held in the Conference Hall of the University on Monday, 4th February 2019 at 10.30 p.m.

The Vice Chancellor was in the Chair and she welcomed all the members to the second meeting of the Syndicate.

The Agenda items were then taken for discussion.

Agenda Item No. S- 003 -001: Approval of the Minutes of the second meeting of the Syndicate (S- 002) held on 17th November, 2018

The Minutes of the second meeting of the Syndicate was approved with modification.

Agenda Item No. S -003-002 : Action Taken Report of S- 002

The Syndicate endorsed the Action Taken Report of S-002.

Agenda Item No. S – 003– 003 :Mode of remittance of Fee for Applications submitted under the RTI Act, 2005 and for copies of documents

After deliberation the syndicate decided to issue orders for confining the mode of remittance of RTI fee due to the University as follows

1. By Demand Draft or Postal Order drawn in favour of the Finance Officer, APJAKTU
2. Online remittance to University Account No. 67296754815 at State Bank of India, Engineering College Branch, Thiruvananthapuram (IFS Code: SBIN0070268).

Item No. S – 003– 004 : Question paper interchange issue reported from TKMIT.

The Syndicate discussed the matter in detail and concluded that the incident was happened due to the serious lapse of the invigilator in the examination hall. Hence, decided to impose a penalty of Rupees One lakh on the institution. It was also decided to give a chance to the eight affected students to write the concerned subject in the forthcoming examination without charging the examination fee.

Item No. S – 003 – 005 : Issues regarding mistakes in assigning barcodes

The Syndicate decided to circulate an instruction sheet to the invigilators and candidates regarding the procedures to be followed for filling the required information in the answer books. Decision was also taken to conduct training programmes to the faculty in three zones for imparting awareness about the examination management system of the University.

Item No. S – 003 – 006 : **Readmission of Sri Muhammad Fayis- Ratification**

The Syndicate ratified the action of the Vice Chancellor to readmit Sri Muhammad Fayis to S1 Civil Engineering in NSS College of engineering Palakkad. After deliberation it was decided that no fine shall be collected from the institution since there were some technical issues in the e-governance portal of the University regarding the readmission process.

Item No. S – 003– 007 : **Approval of the Graduates Attributes of the University**

The Syndicate approved the Graduate Attributes of the University which was recommended by the Academic Council.

Item No. S – 003 – 008 : **Report on Academic Audit.**

It was decided to conduct one training programme for the Academic auditors before the commencement of the next AY to ensure uniformity in audit. The syndicate has directed to form a subcommittee of the Academic Council to review the Academic audit reports and to suggest suitable modifications in the Academic audit pattern. It was opined that the subcommittee has to explore the possibility of limiting the Academic audit once in a year to accredited colleges and also to allot two days for each Academic audit to institutions having more UG and PG programmes

Item No. S – 003 – 009 : **Budget for the year 2019-20**

The members of the Syndicate demanded more time for the detailed study of the proposed budget for the year 2019-20. It was decided to constitute a four member subcommittee of the Syndicate with Dr. Mohandas V. P. as the convenor and Dr. Radhakrishna G Pillai, Dr. Sudha T. and Sri. C. C. Udayan (Finance Officer) as members. Hence, the item was deferred to consider in the next meeting of the Syndicate in March first week.

Item No. S – 003– 010 : **Audit report of Local Fund Audit Department for the year 2014-15 and replies to the Audit report.**

The members of the Syndicate demanded more time for the detailed analysis of the audit report and directed the subcommittee with Dr Mohandas V. P. as the convenor and Dr. Radhakrishna G Pillai, Dr. Sudha T. and Sri. C. C. Udayan (Finance Officer) as members to study and present a report on Audit report along with the proposed budget. Hence, the item was deferred to consider in the next meeting of the Syndicate in March first week.

Item No. S – 003–011 : Annual Report and Accounts for the year 2017-18

The item was deferred to consider in the next meeting of the Syndicate in March first week.

Item No. S – 003 – 012 : Affiliation fee of institutions for the Academic year 2018-19

The Syndicate approved the direction of the 8th meeting of the BoG regarding the remittance of affiliation fee for the Academic Year 2018-19. Hence it was decided not to impose fine to the institutions which remit the balance affiliation fee before 31/12/2018 and to impose a fine of Rupees Fifty thousand to the institutions before 31/3/2019. It was directed to publish the list of colleges in the website of the University whose balance affiliation fee is pending with a direction to remit the fee before 31/3/2019 failing which, the affiliation for the Academic year 2019-20 will be withdrawn.

Item No. S – 003 – 013 : Proposal for approval of conducting and officiating charges for various intercollegiate tournaments.

The Syndicate approved the proposal regarding conducting and officiating charges for organising various intercollegiate tournaments with retrospective effect.

**Item No. S – 003 – 014 : Rajadhani Institute of Engineering and Technology-
Review of fine imposed for admitting students from North-East without prior permission of DTE**

The Syndicate reviewed the decision taken in the last meeting as directed by the 8th meeting of the BoG and decided to reduce the fine imposed on the institution from 10 lakh to 5 lakh.

Item No. S – 003 – 015 : Affiliation process for 2019-20 – Affiliation of institutions offering UG/PG programmes in Engineering & MBA, MCA, Architecture and Hotel Management

The Syndicate approved the proposed schedule of Affiliation process for the AY 2019-20. It was decided to follow the existing affiliation fee structure for the time being. Decision was also taken to obtain financial guarantee from all the institutions since the institutions are now affiliated to KTU only and they can transfer the financial guarantee from the parent university to KTU.



Item No. S – 003– 016: e-Governance system – Development and maintenance on time and material basis for one year- sanction additional resources

Based on the minutes of the meeting of the Vice Chancellor with M/s KELTRON and the Development team the Syndicate has granted sanction to allot 12 more resources (6 senior resources and 6 junior resources) to the development team of M/s KELTRON to complete the development of the immediate requirements to be incorporated in the e –Governance portal of the University. This arrangement is approved till July 2020 only.

Item No. S – 003 – 017 : e- Governance system - Proposal for constituting an IT development team of the University.

The Syndicate approved the proposal for constituting an IT development team of the University and granted sanction to recruit a 10 member team on contract as proposed by giving advertisement and following the procedures as per rule

Item No. S – 003– 018 : Proposal for Software defined Data Centre for the University

The Syndicate approved the proposal for establishing the Software defined Data Centre for the University for an estimated cost of 260 lakh. The Syndicate accorded sanction to procure the various items by inviting competitive tenders as per rule.

Item No. S – 003 – 019 : Legal opinion with regard to the appointment of non - teaching staff of the University

The Syndicate deliberated on the matter and has directed to prepare a detailed regulation for the promotion to the various posts of non- teaching category. Hence the matter was deferred.

Item No. S - 003 -020: Any Other Matter

1) Appointment of Standing Counsel for the University

The present standing Council of the University Adv. Krishnamoorthy was appointed in 2015 and he has completed 4 years in that position. Hence, the Syndicate decided to appoint 'Adv. Elvin Peter P. J., Sarene Castle, Pidiyancheril House, Perumanoor' as the Standing Counsel of the University.

2) Course repeat in multiple courses

Sri. Rahul Ravi, student member has pointed out that there are students with course repeat in multiple courses and it is not possible to schedule classes for these students within the frame work of regular time table. After deliberation the syndicate directed to consider the matter during the implementation of new curriculum from the AY 2019-20.

3) Issues regarding minimum Internal Mark

Sri. Rahul Ravi, student member has pointed out that the University has prescribed minimum internal mark for each course in order to be eligible for appearing for the end semester examination and many engineering colleges are using this as a tool to harass the students. The member demanded to withdraw the minimum internal mark criterion. The syndicate decided to consider the matter during the implementation of new curriculum.

4) Grace Mark for Sports Activity

Sri. Rahul Ravi, student member brought to the notice of the Syndicate that all other Universities in the State are granting grace mark for the students who achieves Medals in sports and games activities at different levels and demanded to follow the same procedure in KTU also. The syndicate has directed to consider the matter in the next Academic Council meeting..

5) Manual for Cultural and Technical Fest

Sri. Rahul Ravi, student member brought to the notice of the syndicate the necessity of preparing a manual for Cultural and Technical Fest for the University. The Syndicate in principle accepted the matter and directed to consider the same after the first state come in exsistance.

6) Duty leave for students

Sri. Rahul Ravi, student member has pointed out that currently the University is not granting Duty leave to the students representing the College/University in Sports activity, NSS programme, College Union Activity etc. Hence, demanded to grant duty leave for the students participating in such activities. The Syndicate directed to place the matter in the nexet meeting of the Academic Council.



7) Staff Strength of the University


As per the demand from the member Dr. Radhakrishna G Pillai, the entire list of the current staff of the University including the permanent, deputation, contract and daily wages was placed for discussion. After deliberation the Syndicate concluded that the current staff strength is so inadequate to carry out the day to day activities of the University and directed to represent the matter before the Government for creating more posts. The Syndicate ratified all the appointments on contract and daily wages made by the Vice Chancellor till date for the smooth functioning of the University. The Syndicate also decided to extend the contract appointment of Sri. Gopakumaran Nair and Smt. Gracy Joseph for one more year.

7) Progress of starting new Departments of the University

The member Dr. Radhakrishna G Pillai, has brought to the notice of the Syndicate the need for starting the Departments in the University. The Syndicate after deliberation directed the Dean (Academic) to prepare a proposal for starting 5 departments in the University with the recommendation of the Academic Council.

7) Implementing Group Insurance scheme for the Students of the University

Dr. K. P. Indiradevi, the Director of Technical education has pointed the necessity of implementing a Group Insurance scheme for the students of the affiliated institutions. The syndicate entrusted the Registrar to prepare a proposal for the same and place it in the next meeting of the Syndicate.
