



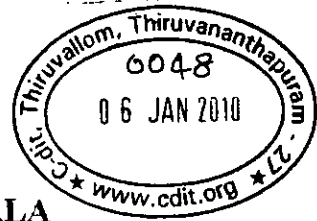

2. Government have examined the matter in detail and are pleased to regularize the appointment of Sri.P.V.Unnikrishnan as Full Time Member of State Planning Board on deputation basis with effect from 24.11.2006 onwards and also with the following terms and conditions :-

P.V.Unnikrishnan (presently working as member planning board who is retaining lien in the post of scientist E2 in C-dit) was appointed scientist E2 grade w.e.f. 23.08.1996 as per proceedings 2nd cited and in the proceedings 3rd cited Shri.G.Jayaraj (Who is now on deputation to the office of the Hon. minister for Health and family welfare, Government of Kerala as special private secretary) was placed in the grade of Scientist E1 w.e.f.01.10.1997. According to the decision of the 48th Executive committee 5th cited Shri.K.Mohankumar was promoted scientist E1 w.e.f.01.10.1998 subject to the condition that the promotion would be reviewed on the basis of the report of the sub committee of the Executive Committee appointed for rectification of anomalies of service matters of C-dit employees.
