AND COMPANIES) AMENDMENT BILL, 2024**

**(Report of the Subject Committee)**

The Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Amendment Bill, 2024 (Bill No.190) was referred to Subject Committee XIV (Home Affairs). Subject Committee XIV considered the Bill clause by clause and now submits its report with the Bill as reported by the Subject Committee annexed thereto.

2. The Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Amendment Bill, 2024 was published as Gazette Extraordinary dated 30<sup>th</sup> January, 2024. The Bill was introduced in the Assembly on 7<sup>th</sup> October 2024 and was referred to the Subject Committee on the same day.

3. The Committee considered the Bill clause by clause at its meeting held on 9<sup>th</sup> October 2024. The Committee recommends to adopt the bill without any modification.

4. The minutes of dissent and the Bill as reported by the Subject Committee are appended.

**THE KERALA PUBLIC SERVICE COMMISSION (ADDITIONAL  
FUNCTIONS AS RESPECTS CERTAIN CORPORATIONS  
AND COMPANIES) AMENDMENT BILL, 2024**

(As Reported by the Subject Committee)

*BILL*

*further to amend the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970.*

*Preamble.*—WHEREAS, it is expedient further to amend the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 for the purposes hereinafter appearing;

BE it enacted in the Seventy-fifth Year of the Republic of India as follows:—

1. *Short title and commencement.*—(1) This Act may be called the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Amendment Act, 2024.

(2) It shall come into force at once.

2. *Amendment of section 2.*—In section 2 of the Kerala Public Service Commission (Additional Functions as respects certain Corporations and Companies) Act, 1970 (19 of 1970), in clause (a), the words, figures, brackets and symbols “or the Kerala Tailoring Workers’ Welfare Fund Board constituted under sub-section (1) of section 9 of the Kerala Tailoring Workers’ Welfare Fund Act, 1994 (16 of 1994)” shall be inserted at the end, before the symbol “;”.
