

ANERT is the State Nodal Agency (SNA) for the Ministry of New and Renewable Energy (MNRE), Govt. of India, to carry out the Centrally Assisted Programmes in Kerala of the First Part

M/S Renewable Energy Care – having its office at Lakshmi Nagar, Pattom, Thiruvananthapuram - A Consortium formed between Urjamithra Service Centres established under entrepreneurship development programme as service centres of Renewable Energy and Energy Conservation equipment and systems as per agreement attached to this as Annexure 1 and which shall be deemed to be an integral part of this MOU (hereinafter called as REC which expression shall, unless the context does not admit, include its successors and assigns), represented by the SURAJ MON M.R (URJAMITHRA KANJIRAPPALLY) on the second part.

## WHEREAS

1. The ANERT is actively involved in the Renewable energy field including but not limited to Solar Power Plants/ Bio Gas projects/ E Mobility/ New Technologies etc. as per the directions of the Government of Kerala & MNRE and Project Management Consultancy services to various Government/PSUs as the Nodal Agency of Government of Kerala and Ministry of New and Renewable Energy.
2. The REC as a collective forum of professional units engaged in works associated with Renewable Energy has expertise and experience in all fields ANERT is engaged with - be it solar or E mobility - with enough Technical expertise / Field experience with inherent ability thereby gained to provide manpower requirements/ services to address projects/ Works allotted by ANERT as per necessity.
3. The ANERT as the nodal agency for MNRE and the professional body established by the Government of Kerala having expertise and professional skills, agree to hire the services of the REC to fulfil the manpower requirements associated with projects as it may deem fit from time to time on the terms and conditions set forth in this MoU.
4. Both parties entered into an agreement whereby ANERT could utilise the strengths of the consortium that complement the requirement of ANERT for the deployment of Renewable Energy resources for their mutual benefits, especially in the implementation of Solar City Thiruvananthapuram.
5. Service charges to the consortium will be as per the common norms issued for Urjamithra centres and other services from time to time. Which will be applicable to other organisations availing services of Urjamithra centres or REC till this MoU is valid and in force.

ANERT will assign the work requirement to REC as and when required along with a timeline to complete the same. REC shall arrange the required manpower with the necessary skill

to meet the requirement. A report on the assigned work has to be submitted to the programme in charge of assigning the same. The report will be verified by the Programme in charge and an acceptance certificate will be issued. Based on the acceptance the charges to the consortium will be released on a biweekly basis.

6. Operation and maintenance of Solar Power Plants, Solar Street lights or any Renewable Energy systems can be undertaken by REC from ANERT or directly from the EPC during the O&M period. The charges will be as per the rate card published by ANERT. It is the responsibility of REC to execute the work to the satisfaction of awarding authority.
7. For smooth and flaw-free communication and operation a desk space will be provided along with the field implementation wing of Solar City.
8. REC may also take up the responsibility of call centre in connection with O&M, Service and maintenance programmes implemented through ANERT.
9. REC can also be entrusted with warrantee responsibility and Operation maintenance of EPC who is not providing O&M and service to the consumer. The expense in this regard shall be charged against retention money or sum forfeited from EPC for non-compliance of tender conditions.
10. ANERT shall also provide Skill up gradation training to the REC team, if required as in the case of other Urjamithra entrepreneurs.
11. All office orders concerning the services hired from REC / have to be hired deemed to be part of this MoU.
12. If any additional work other than existing has to be added to the services, it will be incorporated on mutual consultation.
13. This MoU will be further guided by Govt. orders/guidelines based on it, from time to time.
14. A working group with the following members will be constituted for the smooth functioning of REC with respect to the work assigned by ANERT. Project In-charge, ACTM, CTM and two Nominated members of REC.

### FINANCIAL TERMS

1. General terms and conditions formed as per mutual understanding and included as Annexure 1 attached herewith shall be binding on both parties.
2. The rates for works associated with and agreed upon by both parties attached to MOU as annexures shall be binding on both parties.
3. Procedures/Workflow/ Rates etc. of additional works generated in future which are not covered under existing Annexures may be decided by mutual discussions on a case-to-case basis.

### VALIDITY OF MOU AND ITS AMENDMENT

1. This MoU shall remain in force from the date of signing of this MoU for a period of two years that could be extended for a period as mutually agreed upon by and between the two parties in writing.
2. Except otherwise provided therein, no addition, amendment or modification of any part of the MoU shall be effective unless done in writing and signed by and on behalf of both parties by their respective Authorized Signatories.
3. However, the agreements entered based on the project-to-project case shall be valid based on the mutually agreed terms therein.

## NOTICE

All notices which are required to be given under the MoU shall be in writing and shall be sent to the address of the recipient designated by written notice. Any such notice may be delivered personally, by pre-paid registered letter or facsimile, or email.

## FORCE MAJEURE

Neither party shall be liable to the other for any delay or failure on their part in performing any of their obligations under this agreement, resulting from any cause beyond their control including, but not limited to strikes, fires, floods, earthquakes, explosions, riots, acts of God, acts of Governments, War, Enemy action or political changes, etc.


## COMMUNICATION

2. MoU Signed between REC and ANERT dated 11/04/2023

ANERT had signed a MoU with Renewable Energy Care (REC), Urjamithra Consortium for providing various services- liaison with local bodies, autonomous bodies, public sector enterprises and Government departments. In connection with following directions are hereby issued for compliance.

1. To manage shortage of manpower, ANERT offices can utilize the support services of REC as an extended arm for Promotion activities, Organizing awareness programmes, Formulation of projects, monitoring and service support of Renewable Energy Projects etc. The area of activity assigned to REC shall involve the operation and maintenance of solar power plants, solar street lights, or any other renewable energy systems that REC can undertake. This also includes liaising with local bodies and other departments for site surveys, sourcing deposit works, maintenance of service contracts, etc.
2. REC may also be entrusted to liaise with Government departments, PSU's, LSGD institutions for awareness, formulation of projects, and obtaining deposit work or Consultancy work for ANERT. In such case, REC has to request the concerned district office for the allotment of institutions for liaison for the project.
3. ANERT shall assign work requirements to REC as needed, along with a timeline for completion.
4. In the case of formulation and liaison for getting deposit work or consultancy, REC

will be eligible for 10% of the PMC charge of ANERT. This will be released on getting PMC charges, to ANERT and on commissioning of the project. REC will be responsible to liaison all activities of from project formulation to commissioning of the project.

5. The details of service charge of all activities were already published (A.O.No. 101/2023/ANERT dated 29.04.2023 or its amendments from time to time).

District Offices can utilize REC services for all projects of ANERT under the above mentioned conditions when needed.
