As per the Government Orders read as 1st and 2 nd papers above, Government have constituted a Committee headed by the Chief Secretary to Prioritise the Plan funds of the State for the financial year 2024-25 and issued detailed guidelines for the purpose.

2) Subsequently, the Director Scheduled Tribes Development Department, as per the letter read above, has submitted a proposal for prioritisation of the plan fund for the financial year 2024-25 .

3) Government have examined the proposal in detail and are pleased to issue orders by prioritising the following schemes of the Scheduled Tribes Development Department for the financial year 2024-2025 at 77.74% of the total plan outlay. The two schemes in Sl Nos 37 & 38 of the following table, which comes under the statement made by the Hon'ble Chief Minister in the Legislative Assembly under Rule 300 of the Rules Of Procedure And Conduct of Business in the Kerala Legislative Assembly, has been excluded from prioritisation.
