

2. Minutes of the meeting held on 15/09/2011 chaired by Hon'ble Chief Minister to discuss the issue relating to Industrial Water Supply Scheme for Palakkad.

ORDER

- 1. The Managing Director, KINFRA as per the letter read as 1st paper above has requested to allocate 10 MLD of water from the Malampuzha Dam for the Industrial Water Supply Scheme to Kanjikkode area through Kerala Water Authority out of the 96 MLD being drawn by Kerala Water Authority from the Dam and permit Kerala Water Authority to enhance the drawal from 96 MLD to 105 MLD so that in future KINFRA can avail 20 MLD.
- 2. In the meeting chaired by the Hon'ble Chief Minister on 15/09/2011 at Chief Minister's Conference Hall to discuss the issues relating to the Industrial Water Supply Scheme for Palakkad District, it was decided that Irrigation Department will allow KINFRA to-draw 10 MLD water from the Malampuzha Dam to Palakkad Industrial Water Supply Scheme. Further · allotment will be taken after assessing the availability of water.
- 3. In the above circumstances, Government are pleased to allocate 10 MLD of water to KINFkA for the 1st phase of Development of Industrial park at

Kanjikkode out of the 96 MLD water already allocated to Kerala Water Authority from Malampuzha Dam.
