- S. R. O. No. 365 71.—In exercise of the powers conferred by sub-section (1) of Section 2 of the Kerala Public Services Act, 1968 (19 of 1968) and in supersession of all the existing rules and orders on the subject, the Government of Kerala hereby make the following Special Rules for the Kerala Civil Supplies Subordinate Service, namely:-
- 1. Constitution.—The service shall consist of Assistant Taluk Supply Officers including Junior Superintendents in the District Supply Offices and the Board of Revenue (Civil Supplies), Managers in City Rationing Offices and Taluk Supply Offices and Deputy Tahsildars (Civil Supplies).
- Appointment,—(1) Fifty per cent of the posts shall be treated as addition to the post of Deputy Tahsildar in the Kerala Revenue Subordinate Service.
- (2) Appointment to the remaining fifty per cent of the posts shall be made by transfer from among the members of the Kerala Ministerial Subordinate Service employed in the Civil Supplies Department and, if no qualified and suitable candidate is available for such appointment, by direct recruitment.

- 3. Appointing authority. The appointing authority shall be the Commissioner of Civil Supplies.
- 4. Reservation of appointments.—The rules regarding reservation of appointments (General Rules 14-17 of the Kerala State and Subordinate Services Rules) shall apply to appointments by direct recruitment.

Qualifications.

- (a) Qualification regarding age.—No person shall be eligible for appointment by direct recruitment if he has not completed or will not complete twenty years of age or if he has completed or will complete thirty years of age, on the first day of July of the year in which applications for appointment are invited.
- (b) Other qualifications.—No person shall be eligible appointment as Assistant Taluk Supply Officer by the method specified in column (1) of the table below, unless he possesses the qualifications specified in the corresponding entry in column thereof.

6. Probation. - Every person appointed as Assistant Taluk Supply Officer shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

- 7. Tests.—Every person appointed by direct recruitment as Assistant Taluk Supply Officer shall, within the period of probation, pass the Account Test (Lower) and District Office Manual Test.
- 8. Training.—The probationers shall undergo during the period of probation such training as may be prescribed by the Government or the Board of Revenue (Civil Supplies).
- 9. Unit of appointment, discharge, re-appointment, seniority and appointment as full member.—For purpose of appointment to the service, discharge, re-appointment, seniority and appointment as full member, all the posts in the cadre of Assistant Taluk Supply Officers other than those treated as addition to the posts of Deputy Tahsildars in the Kerala Revenue Subordinate Service, shall form one unit under the Board of Revenue (Civil Supplies).
- 10. Postings and transfers.—Postings and transfers of Assistant Taluk Supply Officers shall be made by the District Supply Officers within the District and by the Board of Revenue (Civil Supplies) from one District to another.

Assistant Commissioner (Movement) and Special Officer (Food Movement), Vijayawada referred to as items 2,4 and 6 under category I in rule I, were abolished as per G.O. (MS) No.12/68/Food dated 3.5,1968, G.O. (Rt) 282/12/Food dated 2.6,1972 and G.O. (Rt) No. 70/71/Food dated 29.3,1971 respectively. Therefore it has become necessary to delete item No.2,4 and 6.

Further, designation of the post of Head Clerks in the District Supply Offices has been changed into Junior Superintendents. There are posts of Managers in the Taluk Supply Offices of Palghat and Malappuram Districts and Deputy Tahsildars in the checkposts in Palghat District. It has, therefore, become necessary to include the posts of Junior Superintendent in the Office of the District Supply Officers, Managers in the Offices of the Taluk Supply Officers and Deputy Tahsildars in the checkpost also in item No. (1) Column (2) under category II in rule 2.

The note under rule I of the Special Rules for the Kerala Civil Supplies Service stipulates that fifty per cent of the posts in the cadres of District Supply Officers and Taluk Supply Officers in the Civil Supplies Department shall be treated as additions to the posts of Deputy Collectors in the Kerala Civil Service (Executive) and the posts of Tahsildars in the Kerala Revenue Service respectively. With a view to settling the claims of the Revenue Personnel for the posts in the Civil Supplies Department, orders have since been issued in G.O. (M) No.17/75/Food dated 27.10.1975 for absorbing Revenue Personnel on a permanent basis against fifty percent of all posts of and above the U.D. Cadre in the Civil Supplies Department as on 1.8.1975, on the basis of the options to be exercised by them. Therefore, it has been come necessary to amend the Special Rules for the Kerala Civil Supplies Service as above.

(This note is not part of the amendments, but is intended to indicate their general purport).

In the Special Rules for the Kerala Civil Supplies Service issued in G.O. (P) No.11/71/Food dated 10.9.1971, the post of Controller of Rationing was omitted as it was temporary. Orders have, however, been issued subsequently in G.O. MS. 17/75/Food dated 27.10.1975 to absorb the Revenue Personnel on a permanent basis in the Civil Supplies Department against the posts set apart for them. The post of Controller of Rationing has now been treated as a selection post in the Civil Supplies Department which has to be filled up accordingly on a regular basis. It has therefore, become necessary to provide for the post of Controller of Rationing in the Special Rules.

The Staff of the Civil Supplies Department is not required to pass any Department Test either in the various Control Orders or Departmental Instructions issued from time to time. A sound knowledge of both is essential for the staff of the Department. Government therefore, consider that "Civil Supplies Department Test" be declared obligatory for Civil Supplies Department Staff for promotion as Taluk Supply Officers and to posts in equivalent grades. It has also been considered necessary that persons appointed by direct recruitment to the above posts should also pass the Civil Supplies Department Test within the period of probation.

The amendments are intended to achieve the above purpose.

In the Special Rules for the Kerala Civil Supplies Service issued in G.O. (P) No.11/71/Food dated 10.9.1971, the post of Dy. Controller of Rationing was not included as there was no post of Dy. Controller of Rationing at the time of issue of the Rules. Orders have since been issued in G.O. (MS) No.42/81/Food dated 16.10.1981 for the creation of two posts of Dy. Controller of Rationing in the Civil Supplies Department. The post of Dy. Controller of Rationing is a selection post which has to be filled up on a regular basis. It has therefore become necessary to provide for the post of Dy. Controller of Rationing in the Special Rules.

In the special Rules, Qualifications have been prescribed for the posts under categories I and IA and these posts are to be filled up by promotion and by direct recruitment. Government now consider that no separate qualification for promotees need be prescribed for the posts under categories I and IA. Therefore the qualifications prescribed in the Rules for posts under categories I & IA in the case of promotees are proposed to be deleted.

The method of appointment to the post of Controller of Rationing is by promotion from the category of Dist. Supply Officers/Asst. Secretaries. Now the post of Dy. Controller above the post of Dist. Supply Officer/Assistant Secretaries has come into existence. Therefore it has been considered necessary to enlarge the feeder category for promotion to the post of Controller of Rationing by including the posts under category IA also.

In view of the urgency of the matter this has not been scrutinised by the Subject Committee.

- 1. These rules may be called the Special Rules for the Kerala Civil Supplies Subordinate Service (Amendments) Rules 1979.
- 2. In the Special Rules for the Kerala Civil Supplies Subordinate Service for rule 2, the following rule shall be substituted, namely:-
- "(2) Appointment Appointment to the various categories of posts specified in rule 1, shall be made as follows:
- (i) By transfer from the following categories in the Kerala Ministerial Subordinate Service employed in the Civil Supplies Department in the order of preference shown:-
 - (a) Head Clerk
 - (b) Upper Division Clerk
- (ii) In the absence of qualified hands for appointment by transfer, by direct recruitment".

(This note is not part of the amendment, but is intended to indicate its general purport).

Rule (2) of the Special Rules for the Kerala Civil Supplies Subordinate Service issued in G.O. (P) 13/71/PD dated 1st October, 1971, stipulates that appointment to the posts of Assistant Taluk Supply Officers including Junior Superintendents, Managers in the City Rationing Offices and Taluk Supply Offices and Deputy Tahsildars (Civil Supplies) shall be made by transfer from among the members of the Kerala Ministerial Subordinate Service employed in the Civil Supplies Department and if no qualified and subordinate is available for such appointment by direct recruitment. In the Civil Supplies Department appointments are being made by transfer from the Ministerial, Subordinate Service of the Department based on the relative seniority of the persons in the U.D. grade. In accordance with the principles enunciated in the Memorandum No. 71256/SD5/65/PD dated 8.10.1965 when there are more than one feeder category for promotion to a post; persons holding feeder categories with higher scales of pay should be considered to have preferential claims. It is considered desirable to amend the Special Rules for the Kerala Civil Supplies Subordinate service to incorporate the principles in the above Memorandum. The amendment is intended to achieve the above object.
