

#### ORDER

University invited application for Provisional Affiliation for starting/enhancement of UG/PG courses for the academic year 2023-24 vide paper read(1) above. Accordingly, the Principal, Government Medical College, Kottayam had submitted application for

starting BPT course for the academic year 2023-24 along with NOC from Government for starting BPT course with an annual intake of 30 seats.

- 2) Accordingly, University conducted inspection at the college and after verifying the inspection report, the scrutiny committee pointed out following deficiencies.
  - · Faculty is appointed as scientific assistants, not as BPT staff
  - · Deficiency in equipment
  - · Deficiency in Books & journals

Since these deficiencies were not rectified satisfactorily, the application was not processed further for the academic year 2023-24.

- 3) Subsequently, the Principal approached University to reconsider the application for the academic year 2024-25 with an undertaking stating that steps have been taken to re designate the post of Scientific Assistant to teaching staff and also the college has initiated necessary steps for the procurement of required equipment & Library books for starting BPT course. The college also submitted an undertaking from Director of Medical Education stating that "All shortcomings/deficiencies including dearth of faculty noted by the Kerala University of Health Sciences in connection with the inspection for the Provisional affiliation of BPT course in Govt. Medical College, Kottayam for the academic year 2024-25, will be rectified/corrected before the admission of students in the academic year 2024-25."
- 4) Considering the undertaking from Director of Medical Education, the Sub Committee of the Governing Council recommended to grant Conditional Provisional affiliation to Government Medical College, Kottayam to start BPT course with an annual intake of 30 seats for the academic year 2024-25 with the e-mail: keralahealthuniversity@gmail.com Phone: 0487-2207664, 2207642 Fax: 0487 - 2207616, 2207620

condition that all the deficiencies noted during inspection shall be rectified before the admissi systems in the academic year 2024-25, vide paper read (3) above.

Based on the (a) decision read (4) above, the University had directed all the affiliated colleges submit an affidavit in the specific format as given by the University regarding the payment of GST, and the college has not submitted the same till date.

6) Vide decision read(5) above, the 80th Governing Council has resolved to grant Conditional Provisional affiliation to Government Medical College, Kottayam to start BPT course with an annual intake of 30 seats for the academic year 2024-25 on the condition that all the deficiencies noted during inspection shall be rectified before the admission of students in the academic year 2024-25 and the undertaking regarding GST shall be submitted within 3 months...

In the circumstances, as per clause 2 (5) ix (16) of the first statute amended on the matter of affiliation, sanction is hereby accorded to grant Conditional Provisional affiliation to Government Medical College, Kottayam to start BPT course with an annual intake of 30 seats for the academic year 2024-25 on following conditions.

- i) All the deficiencies noted during inspection shall be rectified before the admission of students in the academic year 2024-25.
- ii) The college shall produce an Undertaking in Stamp Paper worth Rs.200/- within three months from the date of issue of this order stating that; "We are aware that no GST is charged on the affiliation and other fees paid by us to the Kerala University of Health Sciences. We do hereby undertake to pay to the university any GST amount along with interest/penal interest charged on the affiliation and other fees, paid by us, if the same is levied by the authorities in future."
- iii) The college shall also produce an undertaking to the university within seven days from the date of receipt of this order that the loss suffered by the students admitted to the college shall be compensated by the College as determined by the university, in the event of this conditional affiliation not made absolute due to the failure by the college in fulfilling the conditions stipulated herein.
- iv) If the conditions noted above are not satisfied within the period stipulated, the Conditional Provisional Affiliation now granted shall cease automatically as stipulated in the affiliation statute 2(5) ix (16).

The college shall strictly adhere to the following conditions:

- · Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- · Affiliation granted is strictly provisional and only for the academic year 2024-25. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University.
- · Admission to the next academic year shall be made only after obtaining prior permission from the University.

Agenda No. 80.53: Academic-AHS-Granting of Conditional Provisional Affiliation to Government Medical College, Kottayam for starting new course BPT with an annual intake of 30 seats for the academic year 2024-25.

1.In response to the university notification, the principal of Govt. Medical College, Kottayam had submitted application for starting BPT course with an annual intake of 30 seats for the academic year 2023-24. The college has submitted NOC from Government for starting the course.

- 2. University conducted inspection at the college and after verifying the inspection report, the scrutiny committee pointed out the following deficiencies.
  - Faculty are appointed as scientific assistants, not as BPT staff
  - · Deficiency in equipment
  - Deficiency in Books & journals

3.The deficiencies were intimated to the college and the college had not furnished a satisfactory compliance report towards rectification of deficiencies and hence the application was not processed further for the academic year 2023-24.

- 4. Later, the college approached University to reconsider the application for the academic year 2024-25 with an undertaking stating that steps have been taken to re designate the post of Scientific Assistant to teaching staff and also the college has initiated necessary steps for the procurement of required equipment & Library books for starting BPT course.
- 5. The college also submitted an undertaking from Director of Medical Education stating that "All shortcomings/deficiencies including dearth of faculty noted by the Kerala University of Health Sciences in connection with the inspection for the Provisional affiliation of BPT course in Govt. Medical College, Kottayam for the academic year 2024-25, will be rectified/corrected before the admission of students in the academic year 2024-25."
- 6. The Sub Committee of the Governing Council recommended to grant Conditional Provisional affiliation to Government Medical College, Kottayam to start BPT course with an annual intake of 30 seats for the academic year 2024-25 with the condition that all the deficiencies noted during inspection shall be rectified before the admission of students in the academic year 2024-25.

7.As per decision on agenda no. 62.09 in the Governing Council meeting held on 26.12.2020, the University had directed all the affiliated colleges to submit an affidavit in the specific format as given by the University regarding the payment of GST. The Hon'ble Vice Chancellor has ordered sanction to grant conditional Provisional Affiliation for the Academic Year 2024-25 to the colleges which are denied/ not responded to undertaking regarding GST subject to the condition that the undertaking shall be submitted within 3 months.

8. The Colleges has not Submitted the affidavit regarding GST.
