ORDER

As per the Government Order read as 1st paper above, an Expert Committee was constituted to conduct a comprehensive study on the formulation of a common frame work for pay/wage structure of PSUs in Kerala except KSEBL, KSRTC and Kerala Water Authority. The terms of reference of the Expert Committee were fixed as per the Government Orders read 2nd and 3rd above. As per the Government Order read 4th above, Sri. P. Sreekumar, Director, BPE was included as new member of Expert Committee.

2. As per the Government Order read 5th above, Government issued orders implementing the recommendations of the Expert Committee. It was also ordered as per the Government Order read 6th above to entrust the same Expert Committee to conduct a comprehensive study on bringing KSEBL, KSRTC

and KWA under the common framework for pay/wage structure as recommended by the Committee and make recommendations on the same within four months time. Later, as per the Government order read 7th above, orders were issued to stop the operation of the clause "Retirement age of employees in Kerala PSUs" in the Government order read 5th above. It was also ordered that separate orders will be issued after examination of the existing situation in the case of each PSU.

3.In the representation read as 8th paper above, the head of the erstwhile Expert Committee, Sri. N. Sasidharan Nair, Former Chairman, RIAB requested to reconstitute the Committee as he is not holding the post of Chairman, RIAB now.

4.Government, after due consideration of the issue, are pleased to reconstitute the Expert Committee constituted as per the Government Order read 1st above, for conducting a comprehensive study on bringing KSEBL, KSRTC and KWA under the common frame work for pay/wage structure in tune with the report of the erstwhile Expert Committee, as follows:

- 5. The terms of reference of the reconstituted Expert Committee shall be fixed as follows:
- i. To examine the scope of bringing KSEBL, KSRTC and KWA in the common framework for pay/wage structure in tune with the recommendations of the erstwhile Expert Committee, implemented by the Government as per the Government Order read 5th above.
- ii. To fix the parameters for examination of the enhancement of retirement age in State PSUs on a case to case basis as ordered in the Government Order read 7th above.
- iii. To examine whether all the recommendations other than that of Retirement Age of Employees in Kerala PSUs in the Government Order read 5th above shall be made applicable to all PSUs registered either under Companies Act or Statutory Company/ Corporations.
